## DIRECTIONS FOR USE

When using the mask you must read and follow the following information. Failure to follow the instructions for use can lead to illness or death.

- The user of the mask must be trained to use it correctly
  - Only for use for infection protection
- Atemious Pro** masks do not protect against gases and vapors.

- The oxygen content in the breathing air must be minimum 19.5% vol.
- Respiratory protection must not be used if the concentration, nature and property of the hazards are not known.
- The mas has to be changed immediately if it is damaged or the breathing window level increases. After the end of a work shift the mask must be changed in principle.
- Never make changes to the mask.

## INSTRUCTIONS



1. Wash hands before touching the mask. Take the respirator out of the packaging, unfold it and pull the ear band firmly in both directions. Inspect the mask visually for damage.



2. Place the respirator in your hand with the nose area facing up. Now direct the respirator to your face first insert your chin, then pull the mask over your nose. Fix the side of the ear bands.



3. For a firm fit, it is necessary to adjust the clip in the nose area to contour the face. Warning: hair like beards can affect the required firm fit of the mask and can cause leaks.



4. Checking the tightness - cover the mask with both hands and exhale vigorously. With slight pressure exhale in the mask, no air should escape the edges. When used correctly, the filter material moves slightly when inhaling.

## STORAGE AND SHELF LIFE

Shelf life when properly stored max. 3 years. Check expiry date on masks before use. Storage and transport clean and dry between -5°C to + 25°C at max. 60% humidity in original packaging. Protect against UV radiation!

## DISPOSAL

In the event of damage, high pollution or if the breathing resistance is significantly increased, the mask should be changed and disposed in accordance with regional regulations.

## CONFORMITY ASSESSMENT

The particle filtering half mask meets the requirements of the European Directive (EU) 2016/425.
